Boat Description

May 15, 2002

The " MV Native II " is a 50 foot by 12 foot custom designed covered tour boat built in 1993 by the Owens Marine Company Winter Springs, Florida. The boat was put into service late 1993 and has been in continuous service to this date.

The boat is licensed to carry a maximum of 49 people and in its normal configuration 44 people are seated at tables of four with 5 seated in rows behind the tables. The tables are aligned along the outer railing at an angle that provides for a wheel chair accessible aisle from the front of the boat to the rear section. There is overhead lighting for night operations of loading and unloading of passengers.

There is an enclosed flushing marine toilet that is also wheel chair accessible, located directly behind the captain's station for the comfort of the passengers.

The configuration of the boat may be changed possibly limiting the number of passengers, but providing for a 6' banquet for serving purposes or either food or drink and a general stand up congregating area in the rear near the table.

There is a wireless sound system that is available for groups and charters' general announcements or music. AC power for the electronics is provided by a state of the art, silent inverter system, up to 2,000 watts is available.

Boarding is accomplished normally by loading from the front or bow on the dock, or by means of a loading ramp at Blue Springs State Park or steps for beach loading anywhere. The boat may also be loaded from access gates mid-ship on either side.

Due to fluctuating water levels, the ability to load powered wheel chairs or personal scooters may be limited. It will be the captain or a designated representative of St. Johns River Cruises that will make the final decision on the loading of these special conveyances at any particular time based on a personal safety criteria for the rider.

The boat meets or exceeds current safety standards and carries at any given time a minimum of 55 Adult Personal Floatation Devices (over 90lbs.) and 40 Child Personal Floatation Devices (under 90 lbs.) all of the Type I Off Shore Jackets as required by the United States Coast Guard. The vessel is inspected annually by the Coast Guard and is issued a Certificate of Inspection which is displayed behind the helm station. Rounding out the rest of the safety equipment two fire extinguishers aboard, life ring, VHF radio, cell phone and first aid kit.

Your safety aboard the Native II is our first and primary concern!

All captains are required to be licensed Masters with current physicals, CPR and first aid certification. Crews are required to be current with man overboard drills, first-aid and random drug testing through an independent company. Our safety record reflects our diligence and pursuit of excellent in this very critical area of not having a single reporting event since the boat was put in service in 1993.

General Group & Charter Information Effective July 1, 2003

1. **Boat capacity is 49 guests and cannot be exceeded at any time.**
2. **Reservations - Groups**, are recommended for all guests but strongly urged for all groups. This insures that your group will have reserved space on the scheduled cruise of your choice. Please advise your total number 24 hrs in advance, so that the remaining seats may be sold.

Reservations - Charters, is mandatory at all times.

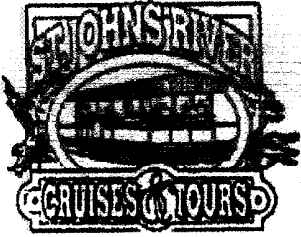
3. **Inclement weather**, while every effort is made to assure a safe and fun cruise, the captain has the final word for the safety of the guests and the operation of the boat. If in captain's opinion the weather conditions exceed the safety envelope demanded by prudent seamanship, the boat will remain at the dock or be taken to the first dock to wait until the conditions improve or the cruise will be terminated. If the boat remains at the dock, no charges for the boat apply. If the cruise is more than half completed based on time, then the cruise will be considered to have been completed.

4. **Alcoholic beverages** for chartered cruises only, may be purchased by the guests, brought on board and consumed on the boat, once the boat is underway. It will be the responsibility of the contact person for the charter / group to retain control over his or her guests. If in the opinion of the Captain or other designated representatives of St. Johns River Cruises, the safety of the boat or its passengers is compromised, the cruise will be terminated, boat returned to the dock with no refunds given. In extreme cases of disorder, law enforcement will be notified to meet the boat..

Alcoholic Beverages are not allowed on the grounds of Blue Springs State Park at anytime. Violators will be expelled and / or cited and arrested !

5. **Food Options**- food is available for charters picked up outside of the park, please ask about one of our fine caterers familiar with the boat, or maybe prepared & served by the chartering group.
6. **Payment** – is expected at the time the boat is loading. For your convenience, St. Johns River Cruises accepts cash, checks, credit cards as follows: American Express, Master Card-Visa, Discover etc.. Other arrangements must be worked out 72 hours prior to departure date.

Driving Instructions

From Orlando:

Via Interstate 4

Take I-4 east to exit 114/54 (Hwy,472) left turn west, follow signs for Orange City, approx. 3.3 miles it will merge with (Hwy 17-92), be in the left lane and it will put you south bound on 17/92. Follow 17/92 south for about 2 miles to stop light, turn right on French Ave 2.2 miles to park entrance on left

Via Highway 17/92

Take 17/92 north through Sanford, over the St. Johns River bridge, after bridge go another 8 miles to French Ave, turn left on French Ave, 2.2 miles park on the left side.

From Daytona:

Via Interstate 4...

Take I4 west to Exit 114/54(Hwy 472), follow signs toward Orange City to Highway 17/92, go 2 miles to French Ave, turn right, park entrance 2.2 miles left side.

From New Smyrna:

Take SR44 past I-4, 5miles to Hwy. 17-92, turn left, going south 5 miles to Orange City, go to traffic light at French Ave., turn right, park entrance 2.2 miles on left

From Titusville & SE coast areas:

I-95 north to Sanford/Mims exit (SR 46), go left (west) on SR46 to 4th traffic light, Hwy. 17/92 (approx. 23 miles), turn right on 17/92 follow over the St. Johns River bridge, then go another 8 miles to French Ave., turn left, park entrance is 2 miles on the left.
